# CARB Regulation Extensions?

We've received numerous reports that the California Air Resources Board is granting extensions for fleets having trouble complying with new diesel emission regulations.

The diesel regulations, which phase in expensive particulate matter filter retrofits and re-engine requirements, have been a looming economic burden for California truck owners, from owner-operators to fleets operating hundreds of trucks.

Diesel trucks have been sold out of state and destroyed by the thousands with to the understanding that they would not be legal to operate in the state.

## **CARB Regulation Schedule**

### GVWR More than 26,000 lbs

Instead, truck owners can report by January 31, 2012 to take advantage of credits and provisions including a 5-year PM filter phase-in option that delays replacements until Jan 1, 2020.

Small fleets (1-3 trucks w/ GVWR more than 14,000 lbs) must report to delay compliance until Jan 1 2014.
